- Reusable equipment (i.e., recirculating system and "halo" water ring/spraying system) used in the provision of personal services to clients were not cleaned and disinfected following the most current IPAC practices that are in accordance with the "Public Health Ontario: Guide to Infection Prevention and Control in Personal Service Settings, 3rd Edition, July 2019".
- Bacteriological water samples obtained from all operational hair washing stations revealed microbial counts above the acceptable limits, as per Public Health Ontario's Public Health Inspector's Guide to Environmental Microbiology Testing, August 2021.
