MECP staff have reviewed the draft addendum report and the hydrological assessment report for your project. We understand that the revised solution includes the following changes from what was described in the original Class EA:

- Convert Well 5 facility into a centralized iron and manganese treatment facility with a treatment capacity 102 L/s and provisions for future expansion.
- Increase footprint of the Well 5 building expansion to house the new treatment equipment.
- Convert Well 2 facility into a raw water pumping station and increase Well 2 capacity from 34 L/s to 41 L/s.
- Construct new raw watermain to connect Well 2 and Well 6 to the new Water Treatment Plant, including provisions for a future well connection for redundancy.
- Increase the capacity of the new Well 6 from 34 L/s to 41 L/s.

MECP is generally satisfied with the reports. Please ensure the final addendum report includes a detailed record of consultation and correspondence with Indigenous communities.

MECP has no objection to the increase in the well capacities in Wells 2 and 6 as described in the addendum report. The Region will require a Permit to Take Water (PTTW) which in turn will require a pumping test.

It is recommended York Region and their consultant engage with the MECP prior to conducting the pumping test to ensure all possible well and environmental interference will be addressed during the test. This consultation will ensure the MECP's concerns are addressed prior to a PTTW application.

A construction dewatering PTTW or EASR may be required for the construction phase of the project. A Hydrogeological Study is required for both pumping tests and construction dewatering permit applications.

The Regional Municipality of York (the Region) completed the Nobleton Water and Wastewater Servicing Municipal Class Environmental Assessment Study in accordance with the Municipal Class Environmental Assessment (Class EA) process for a Schedule C project in November 2021. The purpose of the Class EA was to identify preferred water and wastewater servicing solutions to accommodate the anticipated growth in the community of Nobleton to the 2041 horizon. The recommended water servicing solution included upgrades at two existing Regional water facilities (Nobleton Well 2 and Nobleton Well 5). The recommended upgrades at the Nobleton Well 2 facility, located at 22 Faris Avenue, included an increase in capacity, new building expansion to house associated electrical equipment, and a new chlorine contact tank. The recommended upgrades for the Nobleton Well 5 facility, located at 12860 Hwy 27, consisted of a new production well (Nobleton Well 6), and addition of an oxidation-filtration process for the removal of iron and manganese to improve the aesthetic water quality.
