Hello Maxime,

Thank you for your interest in the project.

A Stage 1 Archeological Assessment (AA) was conducted to establish the archaeological potential of the areas to be potentially impacted by alternative solutions. The following heritage and archeological features were identified in the community:

- Two designated heritage resources: the Mount Albert Methodist (Wesleyan) Pioneer Cemetery at 19015 Center Street and the George Haigh House at 5716 Mt. Albert Road
- Four early cemeteries: Franklin Pioneer Cemetery at 5548 Herald Road; Mount Albert Cemetery at 19675 Centre Street; the Mount Albert Wesleyan Methodist Pioneer Cemetery, and Birchard Family Burying Ground at 5590 Mount Albert Road
- Five registered archeological sites

In addition, some areas were identified as retaining archaeological potential requiring further archaeological investigation (Stage 2 AA) in case construction activities or other soil disturbing activities occur within these areas.

As we proceed through the development of the alternative solutions, every effort will be taken to locate new infrastructure to minimize impacts on these identified areas; however, where this is not feasible, a Stage 2 AA will be undertaken to assess any impact. A Stage 2 AA will be included in the Project File for the Class EA, and a copy will be provided for your files.

A copy of the final Stage 1 AA is attached and will be documented in the Study Project File.
